## 2011 Spring Training Conference in Shell Beach



CSAIA was proud to present this year's 2011 Spring Training Conference at the Cliff's at Shell Beach Resort. This location is a favorite to many members; it is a wonderful venue with breathtaking views of the Pacific Ocean and fantastic facilities for training and speakers!

This year's Spring Training Conference featured instructors from a variety of professions and disciplines. The topics at the 2011 Spring Training included investigating social networking sites and using cell phone information in your investigations, medical aspects of sexual abuse of children, investigating the most difficult sexual assault cases, legal updates, and courtroom testimony from both the defense and prosecution perspective. The medical professionals that joined our 2011 Spring Training were led in course study on subjects such as consent, healing of trauma to the genitals, case peer review, human trafficking signs and symptoms, and preserving forensic evidence.

This was the first time that CSAIA had dual presentations from the perspective of a defense attorney and a deputy district attorney on "Courtroom Testimony." This back to back presentation was successful as evident by the following exit evaluations; "Very worthwhile information presented. I think this is a very valuable class." It was nice to get candid, honest information from the opposing side. Thanks." "It's hard to hate him [the defense attorney]," and "Somewhat disturbing but honest....It helps us know more on warning the victims and pushing the DA."

While overall participation was down due to the statewide budget crunch, over 70 members attended and had fun networking with other professionals in the field of sexual assault investigations. We encourage your comments and suggestions as we strive to bring only the best in training opportunities to our members!

## Legislation

The California Sexual Assault Investigators Association is dedicated to actively supporting legislative changes, which promote our mission. A few California State bills we are monitoring and providing input are:

- SB 534 Victims of sexual assault. Existing law provides that no costs incurred by a qualified health care professional, hospital, or other emergency medical facility for the examination of the victim of a sexual assault for the purposes of gathering evidence for possible prosecution shall be charged directly or indirectly to the victim of the assault. This bill would provide that victims of sexual assault are not required to participate in the criminal justice system or cooperate with law enforcement in order to be provided with a forensic medical exam.

CSAIA agrees that a victim of sexual assault should have access to an evidence collecting examination at public expense and this access should not depend on the victim's cooperation with prosecution. Our concerns are with the potential abuses of the grey area within this proposed SB 534 amendment. CSAIA efforts focus on giving law enforcement more input into preventing abuses, which could create additional uncontrolled costs to law enforcement.

Numerous other questions have also arisen, which is not answered by this bill, as to who will maintain the SART kits (as evidence, considering chain of custody), for how long will these SART kits be maintained, will any testing be conducted on the contents and mandated reporting requirements.

- SB 39, This bill would prohibit the import, production, manufacture, distribution, or sale of caffeinated beer beverages, as defined, at retail locations within the state.

Just about every sex crime detective has seen a case where this type of beverage was involved in a sexual assault of an intoxicated female. Because of this the Board has voted to support this bill.

- SB 622, Existing law, the Sex Offender Registration Act, requires persons who have been convicted of specified crimes to register as sex offenders, including persons who have been convicted in any other court, including any state, federal, or military court, of any offense that, if committed or attempted in this state, would have been punishable as one or more specified sex crimes.

This bill would instead require registration for any person who has been convicted based on the elements of the conviction offense or proven or stipulated facts in the record of conviction, as specified, would have been punishable as one or more of the above-referenced specified sex crimes.

Existing law provides that there is no registration requirement unless the out-of-state offense contains all of the elements of the specified California offense. This bill would instead provide that any person convicted of a statutory offense that is described as a sex offense in the state of conviction for which registration as a sex offender is required in that state shall be required to register under the act except that, for offenses similar to specified California offenses *offenses*, there is no registration requirement unless the out-of-state offense, based on the elements of the conviction offense or proven or stipulated facts in the record of conviction, contains all of the elements of the specified California offense.

# Board of Directors Candidate Information Sheet

## California Sexual Assault Investigators Association

### Board of Directors Candidate Information Sheet Election 2011

The California Sexual Assault Investigators Association (CSAIA) is an organization dedicated to providing training in all aspects of sexual assault investigation. The Board of Directors meets regularly and also works outside the meeting times to develop and provide training each year. Eight (8) open Board of Directors positions are elected at the end of each odd-numbered year.

According to the CSAIA bylaws:

All members in good standing of the Association are eligible to submit their name for election to the Board of Directors. The Board of Directors positions shall be selected in a general membership election where all members in good standing may vote. This election process shall be completed no later than the first day of December of odd-numbered years.

Further, the CSAIA bylaws declare that:

#### **2.2 – Terms of Office**

The term of office for a member of the Board of Directors shall be two (2) years, with the term beginning on the first day of January of even-numbered years, and ending on the thirty-first day of December of odd-numbered years.

#### **2.3 – Board of Director Elections**

The Board of Directors shall be elected by a simple majority of those members of the Association that are eligible to vote. The votes shall be counted by the incoming President and the outgoing President. All Board of Director positions are elected during a general membership election, with the exception of the incoming President and the outgoing President.

#### **2.4 – Board Composite**

The Board of Directors shall consist of a minimum of 60% sworn police officer members or retirees as defined under section 830 of the California Penal Code.

**Additional Requirements for members of the Board of Directors:**

- Commitment shall be for a two year term (January 1, 2012 – December 31, 2013)
- Board members shall prepare for and attend up to nine (9) Board meetings per year. All transportation costs are reimbursed.
- Board members shall prepare for and attend two (2) one-week training conferences per year. In general the training conferences will be held in March and October each year. All transportation and lodging costs are reimbursed.
- Each Board member shall be responsible for additional time commitments based on various committee assignments and duties as assigned to each Director.

It is imperative that each candidate Board member obtain advance permission from his/her agency employer before running for a position on the Board. In an average year, each Board member will spend approximately 24 days per calendar year away from his/her agency for each of the two year term.
